## TERMS AND CONDITIONS & AGREEMENT

Supervisor Nancy Schoenmakers shall not be held liable for any of the following circumstances or consequences arising before, during, or after the photography course, including travel to and from the location:

- Accidents, injuries, or physical harm occurring during any part of the course, including on location shoots, in studios, or during transport.
- Theft, loss, or damage of personal belongings, equipment (including cameras, lenses, and other gear), documents, or valuables.
- Items lost, left behind, or not recovered (lost and found).
- Missed transportation (flight, train, bus, taxi) or delays due to late arrival, cancellations, strikes, or rescheduling.
- Canceled or delayed flights, or denied boarding due to passport/visa issues.
- Illness of any kind, including COVID-19, flu, or other contagious diseases.
- Quarantine or travel restrictions imposed by local or international authorities.
- Absence or inability to participate due to personal or family emergencies, including illness or death of a relative or partner.
- Voluntary withdrawal or cancellation by the participant at any time before or during the course.
- Natural disasters (e.g. floods, earthquakes, wildfires, storms), extreme weather conditions, or other force majeure events.
- Political unrest, civil disturbances, government actions, or other unforeseeable disruptions.
- Injuries or allergic reactions caused by makeup, styling products, or environmental factors on set.
- Personal disagreements or conflicts among participants, models, or staff.
- Emotional distress, stress, or dissatisfaction with the course content, structure, or outcomes.
- Any misunderstanding or misinterpretation of instructions given during the course.

Please note: Under these circumstances, no refunds will be issued.

## Points of Attention

Please carefully read the following points before the start of the course. By participating, you agree to abide by these guidelines.

---

### 1. Respectful and Professional Behavior

A respectful, open, and professional atmosphere is essential. Disrespectful, disruptive, or aggressive behavior toward fellow students, models, make-up artists, or instructors will not be tolerated and may result in immediate removal from the course without refund. Treat every team member, regardless of experience or background, with dignity and equality. Bullying, harassment, or any form of discrimination will result in removal from the course.

---

### 2. Photography Rights and Image Usage

- All photographs taken during the course are for **non-commercial use only** (e.g. portfolio, social media, website).
- Proper credits must always be given: the model, the make-up artist, and **@photographycoursewithnancy** must be mentioned when sharing photos publicly.
- Commercial usage (e.g. selling prints, advertising, brand promotion) is **not permitted** unless all involved parties (including models and make-up artists) provide separate written consent.
- Photographers retain full rights over their own images and may edit and publish them as they see fit (see Section 3 below).

## Photo Editing Clause

### 1. Editing Restrictions

Models and makeup artists are strictly prohibited from editing, altering, or retouching any photographs taken during the shoot. This includes, but is not limited to, the use of software such as Photoshop, Lightroom, mobile editing apps, or AI-based editing tools.

### 2. Authorized Editing

All editing and post-processing will be handled exclusively by the photographer or their designated editor to ensure consistency, quality, and artistic integrity.

### 3. Use of Unedited Images

If unedited images are shared for review or portfolio purposes, they must not be altered or publicly posted without the photographer's written consent.

---

### 3. Creative Freedom & Model Approval

- Models do **not** have the right to select or reject images for publication, except in cases of **explicit, inappropriate, or unsafe** portrayals.
  - Photographers have the creative and editorial freedom to choose their own visual style and post-processing methods.
  - Final decisions about image selection lie with the photographer; there will be no post-course disputes or retouch requests accepted.

### 5. Styling & What to Bring

You bring 2 outfits or rent a dress from the catalogue.

---

### 6. Image Ethics and Styling Boundaries

- Avoid political, religious, or controversial themes in styling, makeup, posing, or image concepts.
  - No use of offensive symbols, messages, or props is allowed.
  - **Nude, semi-nude, or erotic imagery** is strictly prohibited. This includes implied nudity, lingerie-focused shoots, or sexually suggestive styling.

### 8. Insurance, Liability & Personal Responsibility

- You are responsible for your own **travel, health, and cancellation insurance**.
  - Nancy Schoenmakers and the course organizers accept **no liability** for injury, illness, loss of equipment, theft, missed travel connections, or cancellations.
  - A full liability disclaimer is available in your course contract.
- 

### 9. No Guests Policy

- No friends, partners, family members, or other guests are allowed on-site at any time during the course, including during hair and makeup, photoshoots, or group sessions. While you are welcome to travel with a partner, friend, or family member, **they are not permitted to participate in or attend any part of the course activities**.
  - The course requires your **full attention**, and the presence of outsiders disrupts the learning environment.

### 10. Communication

- A **WhatsApp group** will be created to share schedules, updates, and locations. Couple days before the course.
  - Please respond in a timely manner and keep the group respectful and professional.
- 

### 11. Confidentiality & Privacy

- All behind-the-scenes content (e.g. group chats, makeup sessions, private feedback) is confidential and may not be shared publicly without consent.
  - Respect the privacy of your fellow participants and do not publish unflattering or candid photos of others without their permission.
- 

### 12. Behind-the-Scenes Content & Course Documentation

Please note that **Nancy Schoenmakers** will be photographing and filming throughout the course. This includes:

- Behind-the-scenes footage

- Group moments
- Styling, makeup, and preparation sessions
- Photographers while working
- Models during the photoshoots

These photos and videos may be used for promotional purposes on websites, social media, or future course materials.

---

### 13. Independent and Practical Learning Style

This course is designed to offer you freedom, space, and creative responsibility. It is intentionally structured in a **flexible and hands-on** way. You will not be guided step-by-step or constantly supervised — instead, you are encouraged to explore, experiment, and **work independently** with the models and your camera. Nancy will be available for feedback, guidance, and questions throughout the day, but **you are expected to take initiative to create your own image.**

The goal is to **develop your portfolio**, challenge your creativity, and gain confidence as a fashion photographer through real-world practice. This is not a technical beginner’s course — it’s a practical experience for photographers who want to grow, shoot, and build their body of work in a supportive but self-driven environment.

#### Photographer Responsibilities

##### 1. Model Coverage

All participating photographers are expected to photograph **each model** during the course. The goal is to ensure that all models receive equal shooting time and a variety of styles and perspectives.

##### 2. Retouching Requirement

Retouched images must reflect a professional standard suitable for portfolio use and should be delivered within the agreed timeframe.
